

END-USER LICENSE AGREEMENT FOR VISUAL C# KICKS SOFTWARE

IMPORTANT- READ CAREFULLY BEFORE INSTALLING THE SOFTWARE.

This End User License Agreement (this "EULA") contains the terms and conditions regarding your use of the SOFTWARE (as defined below) and material limitations to your rights in that regard. You should read this EULA carefully.

By installing the SOFTWARE, you are accepting the following EULA.

I. YOUR LICENSE TO DEVELOP AND TO DISTRIBUTE.

This EULA grants you two licenses: 1) a license to use the SOFTWARE to develop other software products (the "Development License"); and 2) a license to use and/or distribute the Developed Software (the "Distribution License"). Both of these licenses are explained and defined in more detail below.

1. Development License. This SOFTWARE is licensed to One Developer. You are hereby granted a limited, royalty-free, non-exclusive right to use the SOFTWARE to design, develop, and test Developed Software, on the express condition that, and only for so long as, you fully comply with all terms and conditions of this EULA.

The One Developer License means that you may perform one installation of the SOFTWARE for use in designing, testing and creating Developed Software by One Developers on one computer. You may not network the SOFTWARE or any component part of it, where it is or may be used by more than one Developer.

2. Distribution License. Subject to the terms and conditions in this EULA, you are granted the license to use and to distribute Developed Software on a royalty-free basis, provided that the Developed Software incorporates the SOFTWARE as an integral part of the Developed Software in machine-language compiled format (customarily an ".exe", or ".dll", etc.)

3. Limitations for Use of Source Code. Subject to the terms and conditions in this EULA, Visual C# Kicks hereby grants you the right to use the Source Code. You are hereby also granted the right to modify such Source Code and to create derivative works that are based on the licensed Source Code. You may distribute the derivative works that you develop, solely in object code format and exclusively in conjunction with and/or as a part of the Developed Software. You are expressly not granted the right to distribute, disclose or otherwise make available to any third party the licensed Source Code, any modified version, derivative work, or any portion thereof, in source code format.

Visual C# Kicks shall retain all right, title and interest in and to the licensed Source Code, and all updates, modifications or enhancements thereof. Nothing herein shall be deemed to transfer any ownership or title rights in and to the licensed Source Code from Visual C# Kicks to you.

II. INTELLECTUAL PROPERTY.

1. Copyright. You agree that Visual C# Kicks retains all right, title to and ownership of this Software. In all cases, you may not use Visual C# Kicks name, logo, or trademarks to market your Developed Software without the express written consent of Visual C# Kicks. This SOFTWARE is protected by copyright laws and international treaty provisions. The SOFTWARE is licensed to you, not sold to you. Visual C# Kicks reserves all rights not otherwise expressly and specifically granted to you in this EULA.
2. Backups. You may either copy the SOFTWARE solely for backup or archival purposes.
3. General Limitations. You may not reverse engineer, decompile, or disassemble the SOFTWARE.
4. Software Transfers. You may not rent, lease or transfer this SOFTWARE.
5. Termination. Without prejudice to any other rights it may have, Visual C# Kicks may terminate this EULA and the Licenses if you fail to comply with the terms and conditions contained herein. In such an event, you must destroy all copies of the SOFTWARE and all of its component parts.
6. Export Restrictions. You acknowledge that the SOFTWARE is of U.S. origin. You acknowledge that the license and distribution of the SOFTWARE is subject to the export control laws and regulations of the United States of America.
7. U.S. Government Restricted Rights. : Use, duplication or disclosure by the United States Government is subject to restrictions as set forth under DFARS 252.227-7013 or in FARS 52.227-19 Commercial Computer Software - Restricted Rights.
